1. Background

- 1.1. The Government of Rwanda through the Judiciary, has received funding from the Investment Climate Facility for Africa, ICF to implement the second generation of Rwanda Commercial Justice Project (RCJP) which aims at enhancing contract investors' confidence in the commercial justice system in Rwanda by fully clearing the commercial litigation backlog; reducing the procedures and time for a more efficient and transparent court process; reducing the cost of commercial litigation; improving the quality of judgments delivered; and improving the quality of commercial justice information available to court management for decision making as well as to various stakeholders.
- 1.2. The Judiciary intends to apply a portion of the funds to recruit two individual consultants to execute services for which this Request for Expression of Interest is issued.

2. Main Objective

2.1. The main objective of this assignment is to translate, edit and produce case law reports in English that have drafted by the law reporters of the Judiciary in KINYARWANDA.

3. Duties and Responsibilities:

The translators are required to work on the drafted case law reports in KINYARWANDA and translate them into English.

Responsibilities:

- **A.** The translator will be responsible for translating case Law reports and other relevant legal documents from Kinyarwanda to English ensuring:
 - 1. Complete content accuracy: This entails accurate translation of content, facts and figures, footnotes and endnotes and all relevant legal terminology and no omissions from the source documents.

2. Grammar and style:

Translated documents must be written in excellent English language, expression and grammar.

B. The translator must proofread and edit the final translation and ensure that there are no Typographical errors.
