Ababuranyi (Abavoka, Abashinjacyaha), abacamanza n'abashakashatsi mu nkiko, basabwe kujya bayisoma kugira ngo twese hamwe dufatanye guteza imbere no gushimangira uyu mucu, wo gutanga ibisubizo bimwe ku bibazo bisa.

Tuboneyeho kandi gusaba ababuranyi (Abashinjacyaha n'Abavoka) kuburana bifashishije iyi mirongo, nk'ikimenyetso kitagibwaho impaka gihamya ukuri kw'iby bavuga, igihe basanze bihujwe koko n'ibivugwa mu manza ziri muri iyi nyandiko.
